

End User License Agreement

The CorDEX Software as referred to below is the PDA and RoutePLANNIR™ Software and any other CorDEX software provided to the end user or to which the end user is given access.

END-USER LICENSE AGREEMENT FOR CorDEX SOFTWARE IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: CorDEX Instruments Limited ('CorDEX Instruments'). End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and CorDEX Instruments for the CorDEX Instruments CorDEX Software(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("CorDEX Software"). By installing, copying, or otherwise using the CorDEX Software, you agree to be bound by the terms of this EULA. (a) Installation and Use.
